Population: Approximately 7.3 million people (close to the population of Saitama Prefecture)


Capital: Vientiane


• There were a total of four long-term experts (one prosecutor, two lawyers, and one coordinator) and four Laotian staff members.

• English, Japanese, and Lao were spoken in the office every day!










Contents of the Handbook of Factfinding (Civil)

- The facts leading to judgement in Laos are unclear
- The parties' arguments have not been organized in legal aspect, and the essential facts based on the requirement of each claim rights have not been organized.
- The three-stage organization of claims, facts, and evidence as shown in the diagram on the right has not been achieved.
- Regarding cases of sale, loan, lease, and tort
- 1 What is the argument from the parties
- 2 What is claim rights, requirement
- 3 What is the main issue point







The activity of EDU Group (November 2023 -October 2024)

• We are currently preparing a manual for fact-finding questions (civil cases) in regular meeting(Twice a month 21member)

• In addition, there will be four small group meetings (twice a month in English) to prepare presentation materials for each case.

• A tentative version of the presentation materials summarizing the contents of the handbook will be prepared for each case by June 2024.

• Mock lessons were given to students at the Supreme Court Training Institute and Luang Prabang(northern part of Laos) until October 2024, and revisions were made based on the lessons.





What is the difficulty of working as a legal expert in Laos

• There are almost no basic books that provide a systematic explanation of each basic law. Try to explain abstract concepts such as "claims rights", "requirements," and "issues" as best I can.


• Practitioners, including young generation, are not accustomed to reading provisions "carefully." Have students highlight the wording in each article and imagine how the "requirements" can be based from the articles in civil code.







Sample of teaching material What are main issues in dispute?
 Through court should narrow down the points which is related to legal requirement of the claim rights, have been admitted or denied by defendants(If counterclaim from defendants, plaintiff should admit or deny).
 Main issues in dispute is the points denied by counterparty, which is primarily related to each requirements of claim rights.
